This week the House completed their debate on this year's state appropriation bill, while the Senate continued meeting in committees to get as much legislation as possible discussed before their turn at the budget bill in a few weeks.

SCFB GR staff will continue to listen to our member's concerns, challenges, and ideas, and bring those issues to life for lawmakers in SC and DC. We also encourage our members and the larger community to be active participants in all areas of government – through voting, grassroots initiatives, engaging neighbors in conversation, serving on action committees, or serving as an elected official.

## Weekly Highlights

#### House Budget Appropriations

The House fiercely debated the Fiscal Year 2023-2024 statewide appropriations bill this week, with much of the spirited discussion centering on proposed amendments to nonag related funding. Not many substantive changes were made to the Committee version of the bill and after a few days of long debate, the House adopted their version of the spending plan by Wednesday.

Poultry Science Research Facility - \$3,000,000 non-recurring

Statewide Program Support - \$1,000,000 non-recurring

Problematic Wildlife Research - \$954,400 non-recurring

#### SC State PSA

Agribusiness Development & Expansion Support - \$2,500,000 non-recurring

Agriculture Innovation Research - \$500,000 recurring

#### Forestry Commission

Emergency Operations and Equipment - \$2,250,000 non-recurring

Law Enforcement Retention - \$415,000 recurring

#### Governor's School for Agriculture at John de la Howe

De La Howe Hall Renovation - \$2,100,000 non-recurring

Agriculture Shop - \$1,300,000 non-recurring

Campus Growth - \$1,000,000 recurring

#### DHEC Restructuring – Consolidation of Statewide Water Functions -Heard by Senate Subcommittee

Testimony began in earnest this week on <u>Senate Finance Chairman Harvey</u> <u>Peeler</u> (Senate District 14 - Cherokee, Spartanburg, Union and York Counties counties) and <u>Senate President Thomas Alexander</u>'s (Senate District 1 -Oconee and Pickens County) co-sponsored bill, S. 399, focusing on DHEC reform. This bill aims to increase government efficiency while creating separate health and environmental state agencies, including moving all statewide water regulation into one entity. The bill received overwhelming support last year from the Senate. SCFB is strongly supportive of government efficiency and single agency water.

**SCFB President Harry Ott** testified on the importance of the bill and why we support the increased efficiency and focus on environmental efforts that would be streamlined if passed.



#### Alien Ownership of Real Property Legislation

<u>Senate Majority Leader Shane Massey</u> (Senate District 25 - Aiken, Edgefield, Lexington, McCormick and Saluda Counties) presided over multiple subcommittee hearings on Senate bills 392 and 576, which would change existing law related to land ownership by foreign-controlled adversaries. Current law limits any alien or corporation controlled by aliens from owning or controlling more than 500,000 acres of land.

The working bill, <u>S.576</u>, was amended to include new definitions and limits ownership by foreign adversaries to less than 500 acres. It was passed by the full Senate Judiciary Committee and placed on the Senate calendar for further discussion.

## Statewide Agriculture Agencies Present Budget Requests to Senate Finance

Two agricultural agencies provided their budget requests to Senate Finance subcommittees this week. <u>Commissioner Hugh Weathers</u> and <u>State Forester Scott</u> <u>Phillips</u> provided excellent and informative presentations to their respective subcommittees while requesting ag-focused funding. SCFB GR staff will continue to work with these and other agricultural entities to secure the funding appropriate to support our industry.

At these stops, we'll gather with people in these communities to listen and gain an understanding of exactly how and where improved internet service can impact lives. We'll also invite participants to complete the *Better-Internet Survey* that is designed to pinpoint internet access availability, barriers to use and other concerns around internet use, down to specific household level.
